# **Australia's Disability Strategy**



The government set up Australia's Disability Strategy.

We call it ADS for short.

ADS is the governments way of working together to support people with disability live good lives.



They do this by working with

- People with disability
- The community.

This makes the community a more welcoming place for everyone.



We did a **review** of ADS.

A review is when you check

- What is working
- What needs to change.

This helps us

- Change our plans
- Make **new plans**.

### We talked to



- People with disability
- Organisations that support people with disability.

This is very important.

## **About the review**







We want to make Australia more inclusive.

Inclusive is when everyone can

- Take part
- Feel like they **belong**.

State and territory governments are making plans to support people with disability.

To help us do the ADS review we looked at

- Disability Royal Commission
- NDIS Review

We call it **DRC** for short.



The DRC and NDIS Review helped us look at ADS.



They helped us work out how to make ADS better.

To do the ADS review we talked to

• People with disability



 Disability Representative Organisations

We call them **DROs** for short.

• ADS Advisory Council.



A Council is a group of people that work together to help the government with the ADS.

We call them the Council for short.

The Council is made up of
People with disability
People who understation

 People who understand what life can be like for people with disability.



# **Taking part**



We tested ideas about the ADS

We had 4 workshops with the Council.

A workshop is when people in a group talk about something



We had **5** workshops with DROs.



We wrote a paper.

We had some questions about it.

To make things better people with disability need to be more involved with how ADS

- Works

 All governments need to do more work on their plans in these important areas.



There needs to be more accessible information.

This means everyone can understand it.





People with all experiences need to included in

- Actions
- Reports about the work.

This includes people with disability who come from



• Different cultures



Speak different languages



• Live in same sex relationships



• Are women

• Are children



• Live in cities



• Live in rural areas.

The reports should be about



- All the people with disability who live in Australia
- Their different experiences.

### **Focus areas**



We heard that people think the focus areas of ADS are still good.

They should continue to be important.

The focus areas are



• Employment and financial security

Employment means having a job.



Financial security means having **enough money** to buy the things you need.



• Inclusive homes and communities



• Safety rights and justice

- Prisons.



• Personal and community support



• Education and learning



• Health and wellbeing



• Community **attitudes**.

Attitudes are what people



- Think
- Feel
- Believe.

# **Targeted Action Plans**



People had ideas on how to make **Targeted Action Plans** better.

We call them **TAPs** for short.

TAPs are plans to help us do a **good job**.

• Homes

It tells us to write reports about what we have done.




People think we need to look at more areas to check we are doing a good job.

We are writing a plan to help us do this.




In 2025 we will also have
