The Council helps governments understand how to

- Use ADS
- Share reports about ADS
- Work towards the **goals** of ADS.

Goals are things you want to do.



#### The Council includes people

- With disability
- Who understand barriers for people with disability.




A barrier is something that stops you from doing what you



## **Machinery of government changes**



**Machinery of government** is when there is a change of who is responsible for the work being done.

It might mean a different minister needs to do the work.

We call it MoG for short.



The government makes the changes by putting out new **Administrative Arrangement Orders**.


We call them **AAO** for short.



AAOs say which minister is responsible for work done by the government.



The Council talked about the changes for the disability work in the government.



This could be moving the disability work to **Department of Health Disability and Ageing**.

We call it **DHDA** for short.




**Department of Social Services** will still do the work for disability **employment**.

We call it **DSS** for short.



#### Employment is

- Having a job
- Going to work
- Getting money for the work you do.



The government work for housing will move to the **Department of Treasury**.

## 2025 Workplan



The Council has a 2025 Workplan.

It says all the things the Council will do in 2025.



The **Disability Reforms Ministerial Council** approved the Workplan.

We call them **DRMC** for short.



The DRMC is a group of Disability Ministers from

- The Australian Government
- State and territory governments.

A workshop is when a group of people meet to talk about something.

## **First Nations Disability Forum**



The Council gave **informal advice** to DSS about the First Nations Disability Forum.

Informal advice is when **experts** give their ideas.

Experts are people who know a lot about something.



The Council

• Agreed to the advice




• Added more ideas to the advice.



The advice the Council gave is

 The Council needs to support the views of First Nations people with disability with ADS.

The Council can use **data** to help do this.



#### Data is

- Facts
- Information
- Records.



The Council needs to know how First Nations people want their views to be supported.



 There needs to be better support for First Nations communities to understand ADS.



This could be understanding the **challenges** for Aboriginal and Torres Strait Islander communities.

Challenges are hard things.



This can look different for people who live in

- Regional areas
- Remote areas.



 Understanding different data to check if ADS is working

It is important to break the data down to smaller groups like



- First Nations people
- People with disability.

This helps us know if ADS is working for all people with disability.




The Council can help by sharing **indicators** for

• ADS Outcomes Framework

A framework is how we will do something.



 National Agreement on Closing the Gap.



Indicators are types of information in the data.

This helps us match the same type of information in different data.



 Understanding how to support people with disabilities and the different parts of who they are.

This might change what their experience is like.

This is called **intersectionality**.

## **ADS Outcomes and Accountability**




The Council got information about

- Dougie Herd


Talked to the Council.

## **AHRC** presentation



Rosemary Kayess gave a presentation.

Rosemary is the AHRC Disability **Discrimination Commissioner**.



Discrimination means treating someone unfairly because of something about them they can **not** change.

Like they have a disability.



A Commissioner is the person in charge in an area of the government.

Standards are rules that people need to follow for something.

It makes sure that everyone is doing the same good work.

## **Disability Minister**




The Council met with the Disability Minister Jenny McAllister.
