What are TAPs



The government set up Australia's Disability Strategy.

We call it ADS for short.



ADS is the governments way of working together to support people with disability to live good lives.

They do this by working with

- People with disability
- The community

This makes the community a more welcoming place for everyone.



To make it easier to work on ADS we make lots of small plans.

These small plans are part of the bigger ADS.



The small plans are called **Targeted Action Plans**.

We call them **TAPs** for short.



All governments will work together to do TAPs.

All governments include

- Australian Government
- State and territory governments
- Local Government.





A new TAP called safety **rights** and **justice** was made this year.



Rights are **rules** about treating everyone

- Fair
- Equal.



Justice is

The law



- Police
- The courts
- Prisons.



We want people with disability

- Have their rights respected.

Will help people with disability live safe and happy lives.




The **Disability Royal Commission** looked at how people with disability have been treated.

We call it **DRC** for short.

- Safe
- Respected

- Be able to be supported in all areas of the community.

Harm is when someone is hurt.



We listened to what people with disability said to the DRC.

We wrote the safety rights and justice TAP.



We want better ways to keep people with disability safe.

- Know they belong
- Can take part in the community
